## 2. The information we collect about you.

### Information we collect.

We obtain information about you and any devices (including mobile devices) you use and your use of our Services when you: use our Services, download product information, signup to receive communications or a quote from us, provide us information on a web form, engage or connect with us through our social media pages, or when you otherwise correspond with us. The information we collect can include personal information (as described below) or non-personal information, which is information that does not identify or relate to an individual.

Personal information is information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly, by reference to an identifier such as a name, an identification number, location data, an online identifier, or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person. We collect information through any correspondence that you provide to us whether through email, mail, phone calls, or through our Services. Information that you provide might include, but is not limited to, the following: (a) first and last names; (b) demographic information; (c) mailing address; (d) email address; (e) phone number; (f) credit card number; (g) job title; (h) company name; and (i) other information that personally identifies you.

We do not consider personal information to include information that can no longer be used to identify a specific natural person, whether in combination with other information or otherwise.

## When and how do we collect your information?

We do not require you to provide your personal information to comment, so comments would be non-personal information unless you choose to include personal information.

	<p>Our Services use cookies, unique identifiers and similar technologies to collect information about the pages you view, the Services functions that you access, and the buttons and icons you click to make it easier and more efficient for you to use our Services.</p> <p><b>Cookies.</b> Cookies are small data files that are downloaded onto your computer or mobile device when you use our Services, which are unique to your device. Cookies make it easier for you to use the Services by saving your preferences so that we can use these to improve your next and subsequent visits to our Services. Cookies help us learn which areas of our Services are useful and which areas need improvement.</p> <p>Cookies may be either persistent or temporary (or session) cookies. ## Legitimate Interests

Where we rely on legitimate interests as the reason for processing your information, we have to carry out a balancing exercise to make sure your rights as an individual are not impacted unnecessarily.

We consider that it is reasonable for us to process your personal information for the purposes of our legitimate interests when, on balance, (a) we process your personal information only so far as is necessary for such purpose, and your rights and freedoms do not outweigh such purposes, and (b) it can be reasonably expected for us to process your personal information in this way. In most cases, the information is being processed for your benefit as well as ours.

We have a legitimate business interest in processing your personal information where:

- We need the information to respond to your inquiries;
- We need the information to send you information; or
- We would be unable to provide our Services without processing your information.

If we wish to process your existing information for a new purpose other than as stated above, we must inform you of that further processing and provide information surrounding your information's use.

With your consent, we may use your personal information to:

- Provide you with marketing via email, direct mail, SMS or text
- Provide you with marketing from third parties, including to develop and deliver targeted advertisements to users

## 4. Who we may share your information with.

In connection with our Services, we may share your personal information with the following types of recipients and for the following reasons:

## 5. Your rights and options regarding your personal information.

Your data belongs to you, not us. Therefore, you have choices about how we use your personal information to communicate with you and send you marketing information. You can opt out from receiving future marketing communications from us at any time by:

- The **right to request us to restrict** our use of your personal information (e.g., suspend our use of your personal information).
- The **right to object** to our use of your personal information where we are not using it to perform Services you have requested from us.
- The **right to receive** a copy of your personal information.
- The **right to lodge a complaint** with the supervising authority of your country.

## 7. How long we store your personal information.

We may store your personal information as long as you use our Services to provide you with such Services and for legitimate business purposes.

## 11. Governing law and jurisdiction.

This Privacy Policy shall be construed and governed under the laws of the Commonwealth of Pennsylvania (without regard to rules governing conflicts of laws provisions). You agree that venue for all actions, arising

out of or relating in any way to your use of our Services, shall be in federal or state court of competent jurisdiction located in Blair County, Pennsylvania, within one (1) year after the claim arises. Each party waives any objections based on forum non conveniens and waives any objection to venue of any action instituted hereunder to the extent that an action is brought in the courts identified above.
